### **Official Rules**

#### **1. Eligibility**

Sportsmen's Alliance Protect Your Passion Drawing (the "Drawing") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are twenty one (21) years of age or older at the time of entry.
